BACKGROUND

Academic excellence, character, engagement, and well-being of students are at the heart of Saskatoon Public Schools' strategic plan. CURRENT STATUS

Provide safe on-time transportation for students while minimizing costs.

Key Initiatives Employed:

On-time transportation for each bus company is tracked with a performance log. If a bus company outperforms the other company by providing safe, on-time transportation, they will receive additional bus routes. SPS completes an annual audit with both bus providers, First Student and Hertz. During the audit, these companies are to provide documentation on key risks, SGI carrier reports, detailed documents related to the specific audited bus, driver, route details and evacuation drills.

Cost efficiency of transportation is reviewed during the school year and changes are made to minimize transportation costs.

The key risks to safety noted below are addressed semi-annually with each bus company.

- **Capacity utilization is based on a maximum school bus load of three students per bench seat.

 Students in kindergarten and the early grades may ride at three student/bench seating. Students in older grades needing more space are seated at two students per seat. The capacity rating of buses at three per bench seat overstates the space available for transporting students in older grades.
- ***Students are transported by bus from around the city to intensive support programs and the Cree Language and Culture Program.
- ****Performance metrics are for the school year to date beginning on September 1 and ending as of the date of the column. Total runs are the number of bus route trips to and from school (transportation days each month x number of routes x bus route trips/day).

Key Safety Risks to Transportation:

The information below identifies safety risks (driver competence, student behaviour, vehicle maintenance/condition and external factors) and the strategies implemented to address these risks.

Driver Competence

- 1. Driver evaluations are completed with new drivers after 90 days and annually thereafter.
- 2. Safety meetings are scheduled monthly.
- 3. Each driver's SGI driver's abstract is reviewed annually.
- 4. Companies create left/right sheets for each route. Utilized by regular and sub drivers to ensure accurate route details are available indicating group stop locations, door-to-door addresses, and various other student specific details.
- 5. New drivers work with mentors before driving a route on their own.
- 6. Trainers review driver skills by periodically riding along on each route.
- 7. First Student has a program which provides extra training for drivers who drive routes for special education programs.
- 8. An annual meeting is held in August with all drivers to review safety policies, legislative requirements, and to communicate current information.
- 9. Complaints received are investigated by the operations manager.
- 10. Drivers can complete anonymous surveys regarding training and safety procedures.

Student Behaviour:

- 1. A guideline to safe school bus ride document is distributed to families and includes information for parents/caregivers and students.
- 2. School bus safety rules are posted inside buses.
- 3. Processes are established for managing student behaviours.
- 4. A school bus conduct report is used to support positive student behaviour.

Vehicle Maintenance/Condition:

- 1. Preventative maintenance is performed every three months or 5,000 kms, whichever is first.
- 2. Maintenance is tracked with software.
- 3. Inspection and maintenance are performed according to SGI school bus safety standards.
- 4. SGI inspections are performed annually.
- 5. Staff regularly review reports outlining required inspections to ensure SGI guidelines are met.
- 6. Technicians in bus yards able to assist drivers with immediate concerns.
- 7. Zonar (GPS) systems facilitate identifying maintenance concerns.

External Factors:

- 1. GPS on the buses.
- 2. School buses are equipped with two-way radios allowing for direct contact between drivers and the school bus office.
- 3. Standard accident reports are used to document collisions involving buses.
- 4. Safety checks completed at end of each shift to ensure no students remaining on bus.
- 5. Severe weather procedures are in place in partnership with school divisions.

- 6. Bus information phone hotline and Bus Planner Website provides late bus/cancellation notices.
- 7. School bus loading zones are reviewed during loading and unloading on a rotational basis.
- 8. Front door evacuation drills completed.
- 9. Any safety concerns are noted and addressed.

Future Initiatives:

As the budget process progresses, transportation at schools is reviewed for opportunities to double-loop, resulting in either lower costs by removing a route, or by adding capacity. Discussions with Greater Saskatoon Catholic Schools will continue regarding cost saving opportunities by sharing or double-looping routes. Consideration is made for adjusting bell times at specific schools to allow for double looping opportunities. Implementation of changes to routes and bell times will be made in the 2025-26 school year.

As a result of the additional attendance area boundary change for Sylvia Fedoruk School, new students who live in Aspen Ridge will be offered busing to Willowgrove School in the 2025-26 school year. Families in the southern/central part of Aspen Ridge will continue to be bused to École Silverspring School.

The school division is continuing to move toward more technology, including implementing an app with Hertz Northern Bus for families to access bus route locations. First Student already provides an app for families called First View allowing access to GPS tracking of their specific bus route as well as late bus notifications.

Work continues to create an internal electronic transportation request form for special education students within Clevr. This software program is utilized by the special education department to enhance data collection and workflow processes. By having our transportation form housed within Clevr it will improve communication with schools and streamline transportation requests in a similar format and location that special education teachers are already familiar with.

With one year remaining on the 10-year contract with First Student, preparations for a new joint public tender with Greater Saskatoon Catholic Schools will begin during the 2025-26 school year. Hertz's current contract does not expire until June 30, 2029, with an option to extend an additional three years to June 30, 2032.

Risk Assessment:

While driver recruitment and retention has slightly improved over last year, it remains a risk factor as the school division continues to increase the number of double-looped buses to minimize busing costs, there is a risk to the delivery of on-time bus service. Contracted bus companies are looking to reduce operating costs to improve profitability, which can result in fewer spare drivers and minimized office staff.

A shortage of mechanics has been ongoing since December. This has resulted in additional late runs due to minor mechanical issues.

Transport Canada announced new regulations surrounding school buses. Starting November 1, 2027, all new buses will require perimeter visibility systems, guidelines for optional exterior infraction cameras, and mandatory signage to the back indicating the presence of a camera. Modifications to existing buses are not mandatory. However, the cost of new buses will increase for our contracted bus providers. This could lead to

an aging fleet and more mechanical breakdowns as contractors try to extend the life of current buses or an increase to our upcoming contract if new buses are purchased.

Continued upward pressure on costs for the school division is expected due to price increases within contracts.

Other factors that influence future transportation costs:

- If boundaries are instituted to redistribute enrolment, there is a corresponding transportation cost to the school division.
- If additional special education programs are created, transportation costs will rise accordingly.

Summary Comments:

Transportation continues to provide safe, on-time, and cost-efficient service for students across the school division. Ongoing monitoring of service quality, contract performance, and operational risks ensures that student needs are met within available resources.

Key Initiatives Employed:

Professional Learning

All members of Safe, Caring and Accepting Schools (SCAS) contribute to building capacity within our schools and communities.

- Several key ongoing initiatives include Violence Threat Risk Assessment (VTRA) Levels 1 and 2, Traumatic Event Systems (TES), safeTALK (suicide-alert training), and Applied Suicide Intervention Skills Training (ASIST). Saskatoon Public Schools (SPS) staff who are VTRA trainers worked collaboratively with training partners from Greater Saskatoon Catholic Schools, Prairie Spirit School Division, Saskatoon Police Services, Ministry of Social Services, and Saskatoon Health Region to deliver VTRA to staff from various Community Threat Assessment Protocol (CTASP) partners this year. Staff also had access to LivingWorks Start, an online suicide awareness training opportunity made available by the Ministry of Education. Nearly 300 Saskatoon Public Employees were able to benefit from the training last year, and another 300 are expected to complete by the end of this school year. Other community partners such as Egadz and the City of Saskatoon have been included in safeTALK and ASIST training delivered by SCAS team members.
- SCAS team members continue to work in partnership with the Ministry of Education to achieve the goal of having at least one staff member with Mental Health First Aid (MHFA) Training in each school. Due to teacher and other staff moves that take place each year, some new training is typically needed, and two additional staff members were trained this year.
- SCAS team members have engaged in a variety of other responsive professional learning for staff. For example, vice-principals had the opportunity to attend a session on Therapeutic Crisis Intervention in Schools. The SCAS behaviour consultant also provided learning about Trauma-Informed Practices in Education at a division staff meeting. Many staff also benefitted from consultant and counsellor staff meeting presentations throughout the year.
- SCAS team members worked in partnership with the Saskatoon Industry Education Council (SIEC) Mind Over Matters team to continue to bring Social and Emotional Learning (SEL) resources to schools. The Mind Over Matters team has also engaged with specific schools to provide support and professional learning to school staff. These SEL resources include Elementary Mental Health Literacy, Grades 6-8 SEL resources created through a

- collaboration with SIEC, GSCS, and SPS. New initiatives this year include a weekly mental health tip for school staff featuring strategies like self-care and mindfulness.
- SCAS team members provide resources to all SPS staff through the Staff Well-Being website, focused particularly on emotional and physical well-being. This information is also often shared across platforms using the SCAS Instagram account. They also worked in partnership with Saskatoon Industry Education Council (SIEC) to plan the Mind Over Matters Connecting Minds, Inspiring Wellness Mental Health Conference, which featured topics of neurodecolonization and Indigenous mindfulness, maximizing the benefits and minimizing the risks of AI and technology, and understanding the developing nervous system.

Individualized Planning

Based on a Multi-Tiered Systems of Support (MTSS) framework, universal or tier 1 supports are provided to all students and these meet the needs of most students. A focus on strong relationships, calm classrooms, and achieving curricular outcomes related to well-being are supportive for all students. For students who need more individualized supports (i.e., tier 2/3 in addition to universal supports), increasingly intensive and individualized intervention is necessary.

- Student Incident Reports were introduced in 2022-2023. In completing these documents, administrators are expected to document incidents, and the corresponding intervention(s) employed to ensure student safety and learning. In 2024-2025 school administrators received additional professional development evaluating incidents to determine appropriate documentation and responses.
- Positive Behaviour Intervention and Support (PBIS) Plans capture the team's collaborative
 plan for any student who requires a more intensive level of behavioural support.
 Individualized planning supports the student's well-being and decreases concerning
 behaviour. Consultation from the SCAS Behaviour Consultant also increases the capacity of
 staff to handle challenges, lowers anxiety and promotes well-being across the system.
- Safety Plans are created for students when there is a significant risk of harm to self or
 others. These plans outline steps to be taken in emergent situations to reduce the risk of
 harm. In some cases, students require a suicide risk assessment and safety planning.
 Counsellors supporting students in this way support students and families through crises.
 Subsequent planning and support can help reduce depressive symptoms and increase
 overall safety.
- Case Planning refers to the ongoing work of counsellors, working with students, staff, families and community partners to provide individualized support for educational, social and emotional needs that encourages student well-being. This work is essential to identifying and providing the assistance and intervention in a way that is individualized to the needs of the student.

Safety

SPS collaborates with families as well as partners in policing, social services, health and other community partners to ensure the safety and well-being of students and staff.

- I'm the Boss of Me (ITBOM) is a program for grade 4 students that is the result of an ongoing partnership with the Saskatoon Sexual Assault and Information Centre (SSAIC). Prior to the implementation of Bill 137, nearly all grade 4 classrooms received this presentation related to personal safety. As no third-party presenters have been permitted to present in schools since 2023-2024, the SSAIC created opportunities within the community for families and their children to attend. SPS ensured families were supported in accessing this opportunity by sending information to schools to share with families of students in the relevant grades. ITBOM was presented 10 times between January and March 2025, reaching 383 students. This included 194 students from 27 SPS schools (162 of the 383 students did not disclose their school division and the remaining students were from Greater Saskatoon Catholic Schools) and 336 caregivers.
- Finding the Warrior Within features in school sessions for groups of grade 3/4 students and groups of grade 5/6 students experiencing anxiety that interferes with engagement and learning. In 2023-2024 this program reached 10 groups of students, while 18 groups of students benefitted in 2024-2025. This partnership with Navera Community Connections also includes Steps: From Anxiety to Resilience which worked with six groups of students in three collegiates and one elementary school, and Survivor 101 which benefitted three groups of students at one elementary school and one collegiate.
- No is a Full Sentence (NIAFS) is a program for grade 8 students that focuses on safe and healthy relationships. As no third-party presenters have been permitted to present in schools since 2023-2024, the SSAIC created opportunities within the community for families and their children to attend. SPS ensured families were supported in accessing this opportunity by sending information to schools to share with families of students in the relevant grades. NIAFS was presented 8 times between September to December, 2024 reaching 131 youth and 130 caregivers. SPS attendees included 92 elementary students and 39 collegiate students.
- Violence Threat Risk Assessment (VTRA) Level 1 and Level 2 intervention plans are multiagency support plans that reduce risk and enhance safety. SPS administrative and counsellor teams work closely with policing, social services, health, the SCAS teams, and other partners to complete, enact, and review VTRA intervention plans. In the summer of 2024, VTRA Level 1 and Level 2 intervention plan forms were updated.
- Suicide Risk Assessment Safety Plans are specific plans led by counsellors with Applied Suicide Intervention Skills Training (ASIST) and include an assessment of risk and related plans for mediating that risk.

Traumatic Event Response

When a traumatic event occurs, members of SCAS support school leaders, staff, students, and families in the response.

• SCAS Consultant is primary support, offering consultation but also in-person consultation by attending the school directly when necessary.

- SCAS Coordinator coordinates centrally, ensuring extra counsellors are provided on-site with minimum disruptions to other schools.
- SCAS Superintendent plays an important role from the start of an event, including working with police partners and working with school leaders on initial actions and responses.
- The SCAS superintendent, coordinator, and consultant work together, and closely with leaders, throughout a response, assessing and responding to communication and supporting needs at the school and throughout the division. This support lowers anxiety in the division, allowing staff to maintain or return as quickly as possible to regular routines that are healthy for students.
- Just as other needs grow in the school division as the city grows and enrolment increases, unfortunately so do emergent or tragic circumstances that require support. The average number of responses during the three school years from 2016 to 2019 (i.e., before the COVID-19 pandemic) was 9 per school year. While these types of events did decline during the pandemic, which was typical worldwide, they have increased significantly post-pandemic, with 21 responses in 2022-2023, 24 responses in 2023-2024, and 16 by April of the 2024-2025 school year, for a three-year average of approximately 20 responses per school year.


Data:

Key Measures from OurSCHOOL

Measuring the well-being of students can be difficult. SPS staff use curricula and individualized planning to teach skills to students that help keep them safe and develop skills to cultivate and maintain well-being. To determine if SCAS initiatives are making a difference in student well-being, four consistent measures were selected that all inform levels of student well-being.

Unfortunately, the OurSCHOOL survey was not available for schools to conduct during the regular window in 2023-2024. As a result, there was no OurSCHOOL data to report for the April 2024 accountability report. The survey was conducted after that report was presented. Therefore, this year, 2023-2024 and 2024-2025 will be included for analysis. In 2024-2025, administration determined that only grade 6 and 8 students would be surveyed. Therefore, grades 4, 5, and 7 will not be reported on as they were in past years. In the analysis of the data, the change over two years will be discussed.


Student Anxiety: Students respond to how often they worry about a variety of items including how peers and adults perceive them. A student with moderate to high anxiety reports greater worry in their responses to the questions (e.g., I worry about what other students think about me; I worry more than most kids'). The graph below shows the percentage of students with moderate or high levels of anxiety from the OurSCHOOL survey for the past six years.



Overall, average reported anxiety decreased by two percent from 2022 to 2024. Most significantly, grades eight, nine and ten saw decreasing levels of reported anxiety. In grade six, students reported higher than usual levels of anxiety in the spring of 2024; in the fall of 2024, grade six students were back to 2022-2023 reported levels. Importantly, average anxiety is below the Canadian norm of 32% reported in the OurSchool Secondary survey.

Student Depression: Students respond to items about how often they feel sad and lonely. A student with moderate to high depression will report greater impact from these feelings through their responses to the questions (e.g., I have trouble falling asleep at night; other students seem to have more fun than me'). The graph below shows the percentage of students with moderate or high levels of depression by grade from OurSCHOOL survey for the past six years.




Overall, average reported depression decreased by four percent from 2022 to 2024. All grades, except for grade eleven decreased significantly. Importantly, average depression in Saskatoon Public Schools is below the Canadian norm of 32% reported in the OurSchool Secondary survey. Most importantly, reported depression is lower than pre-pandemic levels across all grades.

Well-Being: Student orientation to well-being distinguishes between hedonic and eudaimonic. The scores on the scale can be treated as a general measure of well-being as both hedonic and eudaimonic measures are correlated with general life satisfaction.


Hedonic Well-Being: This measure includes hedonic items pertaining to values and behaviours, and the pursuit of activities that are pleasurable (e.g., 'I prefer to spend my time doing activities that are fun; I like doing things that are exciting'). This was first measured in 2020-2021 in grades 7-12 and in 2022-2023 for grades 4-6. The graphs below show the percentage of students with a positive hedonic well-being by grade with the data available for the past three years.



Hedonic well-being remained steady at all grade levels. At 87%, Saskatoon Public Schools is just 2% lower than the Canadian norm of 89%. The Canadian norm has also not changed since 2022 – 2023. Hedonic well-being is not as robust a measure as eudaimonic well-being, which goes beyond pleasurable activities to consider well-being in terms of a sense of self and purpose.

Eudaimonic Well-Being: This measure includes eudaimonic items about engagement in personally expressive goals (e.g., 'I spend time developing skills that will further my goals') and eudaimonic items about whether students have a sense of purpose in life (e.g., 'I feel I know who I really am; I can help make the world a better place').



Eudaimonic well-being increased significantly with an overall average increase of 5%. Eudaimonia represents a significant component of well-being given the focus on a sense of self and purpose, and it is important that there is an increase in this area. The only grade where an increase was not realized was grade 12. At 61%, Saskatoon Public Schools is above the OurSchool Secondary survey Canadian norm of 58%.



Training: The total number of employees trained across initiatives increased by 5.9% over the past year. Numbers trained are lowest in areas where only a small number of SPS employees needed training to maintain system goals or requirements. As noted below, most of the training also strengthens partnerships by involving partners in the training. For example, VTRA 1 included a total of 59 participants, VTRA 2 included 56, and TES included 45. One highlight is that a wide range of employees have benefited from suicide awareness training such as safeTALK and LivingWorks Start. Training in safeTALK included participants from varied groups such as educational assistants, driver education instructors, and employees from the human resources department. LivingWorks Start, an online training which employees are granted access to through the ministry, is also expected to reach a wide variety of SPS employees this school year.

Relationships: For the first time, in 2023-2024, administration reported on the target area of relationships. Last year, data from the 2022-2023 school year was shared with the board so the board would have a baseline understanding of how SPS is doing in this area. Relationships are an important marker of well-being; there are two OurSchool measures that capture student-teacher relationships, Advocacy at School and Positive Student-Teacher Relations.


Advocacy at School is a measurement of the number of students who feel that they have an advocate at school who is a consistent provider of support and advice. For this measure, students are asked questions about whether their teacher shows an interest in how they are doing, encourages them, and if they are asked if they are having difficulties at school. Students respond on a likert scale, and the data are scored and reported on a ten-point scale.



Although the Advocacy at School score has not increased since 2022-2023 and has remained fairly stable since 2019-2020, a celebration is that SPS exceeds, with an average of 3.8, the OurSchool Secondary survey Canadian norm of 2.9 in this category.

Positive Student-Teacher Relations is a measurement of the number of students who feel teachers are responsive to their needs and encourage independence with a democratic approach. Students are asked questions about whether their teachers treat them fairly, provide extra help and support and whether their teachers show interest and care. The data are scaled on a ten-point scale and the results are reported as the average score for positive teacher-student relations.



Although Positive Student-Teacher Relations have not increased since 2022-2023, SPS, with an average of 6.7, exceeds the OurSchool Secondary survey Canadian norm of 6.3 in this category by a significant margin.

Rationale and Analysis

Anxiety and depression are significant public health concerns around the world. As the data available over the past six years indicates, anxiety and depression spiked in year two of the pandemic in 2021-2022. Since that year, reported anxiety and depression have been declining and are now essentially at pre-pandemic levels. Overall, initiatives have improved results with decreases depression and anxiety and an increase eudemonic well-being. Hedonic well-being, Advocacy in School, and Positive Teacher-Student Relations remain at similar levels to prior years, however, SPS remains above the Canadian norms in all three of these measures.

Some key points to highlight related to the data available and presented above are as follows:

- In SPS, 40% of the female students and 19% of the male students had moderate to high levels of anxiety. The Canadian norm for female students is 46% and for males it is 18%. Although there are overall decreases in anxiety and depression, drilling into the data further reveals that males currently in grades 8 and 9 report higher than normal rates in these measures. This is something future initiatives should look to address.
- Indigenous Students report much higher levels of anxiety than non-Indigenous students. The gap is larger in earlier grades. For example, in grade 8, the gap is 17% with 26% of non-Indigenous students and 43% of Indigenous students reporting anxiety. However, in grade 12, the gap shrinks to 6% with 28% of non-Indigenous students and 34% of Indigenous students reporting anxiety. Also of note is that the reporting gap between female non-Indigenous and Indigenous students is larger at 28% in the secondary OurSchool survey while the male gap between Indigenous and non-Indigenous is 9%. The data on anxiety mirrors the data for depression with larger gaps occurring in the earlier grades and narrowing by the grade 12 year, as well as more Indigenous females reporting levels of depression than males. This is something future initiatives should look to address.
- In SPS, 89% of the female students and 86% of males reported positive hedonia; the Canadian norm for females is 89% and for males it is 89%. In schools with a replica population, male students are reporting higher levels of hedonia in grades 10, 11 and 12.

Female students are very similar to the replica schools. There is an opportunity to increase opportunities for male students to pursue activities that are fun and interesting to them this is something future initiatives could look to address.

- In SPS, 62% of the female students and 63% of the male students reported positive eudaimonia. The Canadian norm for female students is 55% and for males it is 61%. There is gap between male and female students. Drilling further into the data, the largest gaps between male and female students are at grade 10 and grade 10, 11 and 12. In these grades, females students are reporting higher levels of eudaimonia than replica schools and males are reporting lower. This is something future initiatives should look to address.
- In SPS, female students rated Advocacy in School at 3.4 out of 10 and males rated it 3.6 out of 10. The Canadian norm for females is 2.8 and for males it is 3. Further drilling into the data does not show concerns for male or female students at any particular grade. Indigenous students rated Advocacy in School at 3.5 compared to 3.4 in the secondary OurSchool survey. Supports such as Indigenous Student Advocates, Counsellors, and the Following Their Voices model could all be contributing to this sense of having an advocate at school.
- In SPS, female students rated Positive Teacher-Student Relations 6.5 out of 10 and males rated it 6.7 out of 10. The Canadian norm for females is 6.2 and for males it is 6.3. Further drilling into the data does not show concerns for male or female students at any particular grade. However, there is a discrepancy between Indigenous and non-Indigenous students between 0.4 and 0.5 with Indigenous students rating positive teacher student relations lower except for grade 12, where both Indigenous and Non-Indigenous Students rate positive teacher student relations at 6.5. Conversations and celebrations around graduation and preparation for post-secondary or employment might be one reason for improved relations at the grade 12 level.

Overall, data would suggest that a continued focus on reducing anxiety and depression and improving relationships within schools is essential to student success and well-being.

Risk Assessment:

Mental health and well-being must continue to be an international priority given that approximately 25% of people are likely to experience a mental health condition in their lifetime (United Nations). Approximately 1.2 million Canadian children and youth are affected by mental illness or disorder, and around 20% of young people will develop a mental illness before they turn 25; less than 20% of them receive the right treatment (Youth Mental Health Canada). The recent Saskatchewan Advocate for Children and Youth 2024 Annual Report acknowledges that Saskatchewan faces these same issues, with an increasing number of young people not able to access mental health and addictions support. While partners outside of education are foundational in supporting young people with mental health, the Provincial Education Plan and SPS's strategic plan are right to continue to prioritize student well-being. Investment of resources and energy in creating strong relationships and proactive approaches to well-being are necessary to help students thrive.

Future Initiatives:

To further support student well-being, some examples of key future initiatives are highlighted below:

Comprehensive School Community Health. Comprehensive School Community Health (CSCH) is a whole-school approach internationally recognized for supporting student success while addressing school community health in a planned, integrated and holistic way. CSCH uses the principle that health and education are interdependent, addressed through four integrated components: the social and physical environment, teaching and learning, partnerships and services, and policy. SCAS continues to incorporate elements of CSCH within materials and training. This approach will continue to inform future professional learning and supports that positively impact relationships and well-being.

Specialized Support Classrooms. SCAS supported the design and implementation of the Specialized Support Classroom (SSC) at King George School. The pilot included data gathering, communicating about the project to the community, and serving students and staff with direct intervention and capacity-building. The staff have worked hard to meet pilot goals of creating improved school experiences for students who need additional behavioural support, improving classroom learning environments and reducing stress on classroom teachers to focus on learning. Additional resources related to classroom complexity and specialized support classrooms are expected in the 2025-2026 school year allowing for further support of students and staff at SPS.

Nutrition and Student Well-being. SPS continues to work with partners in the community and the SPS Foundation to provide nutritional supports for students and families. Good nutrition for children and youth supports their readiness for learning and is foundational to student success. This work is done through the lens of Comprehensive School Community Health and Ministry of Education policy documents. SPS embarked on a four-year grant that brought universal lunch programs to two elementary schools this year with the promise of expansion to three more schools in the fall of 2025.

Administrative Procedure (AP) Updates. Administration is developing an AP related to Therapy Dogs in schools, and updating AP 354 (Discipline), AP 355 (Violence), and AP 356 (Weapons).

Partnerships. SPS continues to work with several partners to support well-being. Examples include a continued partnership with Saskatoon Industry Education Council (SIEC) to develop and implement supports for schools. Resources to support both teachers and students in social and Emotional Learning (SEL) will continue to be a priority in partnership work with SIEC. SPS works with Family Service Saskatoon to establish presentations for students related to healthy relationships and well-being. Another example is work with Navera Community Connections. SPS looks forward to enhancing established programs such as *Finding the Warrior Within* with additional student presentations, family presentations and resources, and teacher resources to help support students.

Targeted support from Counsellors and Partners in Health. In response to higher reported rates of depression and anxiety compared to Canadian norms for males currently in grade 8 and 9, and lower levels of hedonia and eudaimonia for males in grades 10, 11 and 12 there will be a targeted approach with secondary counsellors and our health partnerships to explore the data and develop focused programming and supports for our high-school aged male students.

Targeted support for Indigenous student Well-Being. Continued emphasis on supporting Indigenous students, through initiatives such as Following Their Voices, Indigenous Student Advocates, as well as supporting staff with professional learning, will help to improve OurSchool measures for well-being for Indigenous youth. With the expected addition of teaching staff to support classroom complexity, there will be an opportunity for increased intervention and targeted support, which should also impact the next school year results for these measures.

Summary Comments:

To support our students from a holistic perspective, Saskatoon Public Schools must continue to emphasize student well-being as a high priority. The current and future initiatives outlined above ensure that Saskatoon Public Schools is poised to meet the challenge of decreasing anxiety and depression while increasing the well-being of our students through improved advocacy for students at school and student-teacher relations.
